WHEREAS, the Board of Directors (the "Board") of the Tompkins Speech and Debate Booster Club desires to adopt this resolution; and

WHEREAS, the Board has all necessary power and authority to adopt this resolution; and

WHEREAS, the Tompkins Speech and Debate Booster Club is a nonprofit organization established on June 12, 2024, with principal operations located at 4400 Falcon Landing Blvd, Katy, Texas 77494, operating under EIN 99-3603730; and

WHEREAS, Neha Maheshwari currently serves as President of the Tompkins Speech and Debate Booster Club for the 2025–2026 term and is an authorized user and signer on the organization's bank account; and

WHEREAS, Neha Maheshwari's term as President of Tompkins Speech and Debate Booster Club will conclude on June 30, 2026, and she will no longer require access to the Booster Club bank account following the completion of her term; and

WHEREAS, the Board has elected Smitha Vikram to serve as President of the Tompkins Speech and Debate Booster Club for the 2026–2027 term effective July 1, 2026, and she requires access to the Booster Club bank account in order to fulfill the responsibilities of that office; and

WHEREAS, the Board has determined that the authorized users and signers on the organization's bank account should be updated to reflect the leadership transition and current organizational responsibilities;

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Neha Maheshwari shall be removed as an authorized user and signer on the organization's bank account effective July 1, 2026, and that all appropriate steps will be taken to notify the bank and secure her removal from access to this account.



Smitha Vikram, in her capacity as incoming President of the Tompkins Speech and Debate Booster Club, shall be added as an authorized user and signer on the organization's bank account effective July 1, 2026, and all appropriate steps shall be taken to notify the bank and grant her access to the account.

3. The officers of the organization are authorized and directed to execute any documents, forms, certifications, or other instruments required by the financial institution to implement this resolution.


4. Any actions previously taken by the officers of the organization consistent with this resolution are hereby ratified and approved.


